Sealed bids will be received by the City of Lawrence Utility Office at 9201 Harrison Park Court, Lawrence, Indiana 46216 until Tuesday June 17, 2025 at 1:30 p.m. EST for the following:

### **Rehabilitation of the Indian Creek Bridge On Fort Harrison Access Road Over Indian Creek Marion County, Indiana**

After 1:30 p.m. and until 2:00 p.m. EST, bids shall be received in the Public Assembly Room (PAR) located inside the Lawrence Government Center at 9001 E. 59th Street, Lawrence, Indiana 46216.

Bids will be publicly opened and read aloud in the Public Assembly Room located inside the Lawrence Government Center on June 17, 2025 at 2 p.m. EST. Bids received after Tuesday June 17, 2025 at 2:00 p.m. EST will be returned unopened. Bids received by facsimile machine will not be accepted. Only bids from those Contractors who are registered on the Indiana Department of Transportation's current listing of Prequalified Contractors for this type of work included in this project will be considered.

Further information will be posted on the Job Details page of the job posting. Partial sets will not be available. Addenda will be posted to the plan room for downloading and a notification of each addendum will be emailed from the plan room to each plan holder.

**Bid Documents:** All bids shall be accompanied by (1) Bid Form included in the bidding documents (2) completed Form 96 (Ind. State Board of Accounts - Rev.) with required attachments (3) Non-discrimination affidavit as required by the laws of the State of Indiana, and (4) Bid security, as described below (5) Other bidding documents as described in the instructions to bidders.

**Bid Security:** Bid Security in the amount of five percent (5%) of the Bid shall accompany each Bid. Bid Security may be in the form of a Bid Bond (A-310), certified check or cashier's check. If the Bidder withdraws a bid within sixty (60) days after the opening date, without consent of the Owner or fails to execute a satisfactory contract within ten (10) days after notice of acceptance, the Owner may declare the Bid deposit forfeited as liquidated damages.

**Bonds:** The successful Bidder will be required to furnish Performance and Payment Bonds for 100% of the Contract Sum.

The Owner reserves the right to accept or reject any Bid and to waive any irregularities in the bidding. All bids may be held for a period not to exceed 60 days, or as otherwise stated in the Contract Documents before awarding the contract.
