Sealed Bids for the Town of Zionsville West Regional Lift Station will be received by the Town of Zionsville ("Owner") at the office of Beam, Longest, and Neff, LLC. ("Engineer"), located at 8320 Craig Street, Indianapolis, IN 46250, until 9:00 A.M., local time, on December 4, 2020 at which time the Bids will be publicly opened and read. Each Bid should be clearly marked "Attn: Drew Wilson" and "BID ENCLOSED for WEST REGIONAL LIFT STATION" on the outside of the envelope. Bids received after that time will be returned unopened. A conditional or qualified Bid will not be accepted.

An optional pre-bid meeting will be held virtually at 9 A.M., local time, on November 20, 2020. All prime contractors, subcontractors, utilities, small, minority or women business enterprises, and other interested parties are invited to attend. The Project, which is locally funded, will be constructed in one (1) contract division. In general, the work consists of providing all labor and material for the construction of a duplex submersible lift station and the extension of a new sanitary force main to an existing lift station.

Bids must be submitted on the forms found in the Bid Documents and shall be accompanied by a Bid Bond in the amount of five percent (5%) of the amount bid with satisfactory corporate surety or by a certified check on a solvent bank. The successful bidder will be required to furnish satisfactory Performance and Payment Bonds in the amount of 100% of the Bid.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 30 days after the Bid opening.

The Owner reserves the right to reject any and all Bids in whole or in part in accordance with IC 5-22-18-2. The Owner also reserves the right to waive irregularities in any Bid, and to accept any Bid, which is deemed most favorable to the Owner.
