This Addendum No. 1, consisting of 3 pages, shall clarify, correct, or change the Bidding Requirements or the proposed Contract Documents. This Addendum is a part of the Bidding Requirements and the proposed Contract Documents and shall govern in the performance of the Work.

**PART 1 - PROJECT MANUAL**

**1.1 – ITEM NO. 1 – SECTION 00311 – PERMITS**

- A. The approved Posey County ROW Permit has been added to Section 00311.

**1.2 – ITEM NO. 2 – SECTION 00315 – DRAWINGS**

- B. The Legend & Notes sections on the drawings in Section 00315 have been updated to show the service lines as 1.25”.
- C. The Notes section on the drawings in Section 00315 have been updated to the correct lengths of pipe for each installation method.

- D. A note was added to the Sheet 1 detail stating: "Connection to the existing force main shall be done with an electrofusion tapping tee suitable to tap a force main under a live connection. This tee shall be a Elofit Tapping Tee with Belt SDR 11 or approved equal."
- E. The Sheet 1 detail was updated to callout that the 6" lateral as SDR26 PVC.
- F. The note on the Sheet 1 detail for the connection to the existing home lateral was updated to callout a connection with a Hymax coupling.
- G. The Overton & Hoehn drawings in Section 00315 have been updated to shift the valve pit onto the homeowner side of the road.

### 1.3 – ITEM NO. 3 – SECTION 00410A – BID FORM ATTACHMENT A

- A. Pay Item #2 has been updated to be noted as an "Allowance".
- B. Bid Form Attachment A quantities have been corrected for pay items 4.01 and 5.01 to 440 LF and 645 LF respectively, to match the drawings.

The following questions that did not warrant revisions to the Contract Documents have been presented by potential bidders for the **I-64 Black River Rest Stop Grinder Pump Connections** Project. Responses to these questions are provided below. These questions and responses serve only to clarify the Bidding Documents and the Contract Documents, as applicable. The responses to these questions do not modify in any respect the conditions and provisions of the Contract Documents. In the event of a conflict between these responses and the Contract Documents, the provisions of the Contract Documents shall supersede these responses.

**Q: Is the contractor responsible for removing the old septic tanks?**

R: It is a part of the \$50,000 allowance item under Sitework, and the local county requirements must be met.

**Q: Can the contractor pump out the old septic tanks themselves and haul contents to the drying beds at the sewer plant or will a licensed hauler need to remove it?**

R: Similar to above, the local county requirements must be met for this as well. If it was not clear, this is also a part of the \$50,000 allowance item to work through some of those issues during construction.
